Hande Ümit Tarıkâhya completed her undergraduate degree at Middle East Technical University and joined STFA Construction Co. where she worked as Cost Estimation Engineer for 5 years. Then she joined Kutlutaş Construction Co. Power Plants Department and worked in the capacity of Planning Engineer for 3 years.

Her next employment was with Bayındır İnşaat –Yuksel İnşaat JV (member of the Consortium with Siemens AEG Breda) for the Ankara Light Rail Transit System (Ankaray Project) which lasted for 5 years. She was employed as the Technical Office Chief in charge of the Upstream Contract, Consortium Agreement and Project Scheduling.

On completion of the Ankaray Project Ms. Tarıkâhya joined Yuksel İnşaat A.Ş. (Yüksel) . In the meantime she attended evening classes at Ankara University Law School for one academic year and received her post graduate degree (July 2000) in Construction Contracts and Dispute Resolution. She was actively involved in the international commercial arbitration (ICC, UNCITRAL) and madiation procedures in which Yuksel was a party. She attended various seminars and workshops organised by International Chamber of Commerce in various countries. Ms. Tarıkâhya worked as the Contracts Group Manager of Yüksel Holding Group of Companies for 15 years and performed the following duties:

Studying tender documents for preparing reports to the company management to make "bid-no bid" decisions, contract negotiations

Drafting and negotiating partnership agreements, subcontracts, consultancy agreements, etc.

(b) Post-Contract Execution Stage

Contract Management and Claim Management for local and international projects of Yuksel. Worked as the manager of the Yuksel Contracts Group comprised of in-house lawyers . The job involved close cooperation with the local law offices of the countries in which the projects were related. Thus familiarity with various law systems worldwide were acquired.

Ms. Tarıkâhya managed US Government Contracts – in contact with US Law Firms- executed by Yuksel in Afghanistan and Iraq for more than 10 years. During the said period she was also in charge of partnership agreements/ subcontracts with US Private Sector companies.

After completing more than 30 years in active professional life she retired in March 2015.

During the academic term of 2015 - 2016 she worked as Parttime Instructor at Atılım and TED Universities on International Contracts Management

In September 2016 She joined Limak Kuwait SPC, for a period of 12 months, for Kuwait International Airport New Terminal Building Construction Project having Contrat Price USD 4.33 billion. She held the Contracts Director position in charge of Main Contract and Subcontracts; reporting to the Project Director and worked in contact with reputable local law firms She left the Project in December 2018 for retirement.

Ms. Tarıkâhya is a trained radio/tv announcer and public speaker. She is a reader in Six Point Blind Association.
